The ABU Education Fund continued its efforts to make Utah government more transparent to Utah citizens This was done through continued work with the Ed Fund's "follow-the-money" database, which allows citizens to search all track donations and expenditures to/from political candidates The Ed Fund's database allows campaign donation searches to cross donors, political organizations, candidates, election cycles and more in a single search Information can then be exported and further manipulated In addition, the Ed Fund used OpEds, Letters to the Editor, earned media, and radio appearances to bring attention to current issues, including Medicaid expansion, budget issues, open government, public land management, and more The Ed Fund does not expressly advocate for a particular position but rather uses its voice to educate and provide resources for consideration of the issues
