Patients came from diverse ethnic and socio-economic backgrounds, many without the means to access these critical supplies without the support of the CareBOX Program. CareBOX Program provides critical nutritional supplements, infection prevention supplies, and mobility items to assist patients in their homes throughout treatment. Community volunteers pack and deliver the CareBOXes directly to the patients homes to allow caregivers to stay where they are needed most, by the sides of their loved ones. The items provided are used on a daily basis to improve the quality of care for the recipient.

CareBOX Program became the central program and mission of Affect Change. All other significant efforts were redirected to this program in an effort to build the infrastructure to provide care supply products (not covered by insurance) to cancer patients. The CareBOX Program was developed to help prevent malnutrition, infections, and falls for individuals with cancer.

The CareBOX Program curated a list of essential care supplies that cancer patients need to help prevent malnutrition, infections, and falls.

In order to get these supplies to cancer patients, the CareBOX Program developed and launched a crowdfunding website

(CareBOXProgram.org). In 2015, the CareBOX Program connected with major Austin area cancer centers to provide 69 cancer patients with critical supplies and has a goal of scaling to serve 500 patients in 2016. These patients will all receive custom CareBOXes full of nutritional supplements, infection prevention supplies, and mobility items delivered directly to their doors via volunteers.

The CareBOX Program helps cancer patients know what items they will need and has removed all barriers to them accessing these supplies.

Many patients served would have to go without these supplies if the CareBOX Program did not exist.
