Malnutrition Clinic (Africa) - The clinic provides therapeutic milk to starving children. Some Educational opportunities are also provided to mothers to help promote choices that lead to better infant health

4c (Code) (Expenses \$ 128,067 including grants of \$ 127,122) (Revenue \$ 67,072)
Other Projects - Saving Moses provides financial support to orphanages and other providers that offer help and assistance to needy children in areas and situations that no other help is reasonably available. During the year funds were also provided to four rural clinics in Afghanistan to support trained midwives and postnatal vaccinations. Funds were also provided to Sierra Leone and Liberia to take care of babies orphaned by Ebola. Saving Moses supplied orphanages with funding for nurses, caregivers, medicine, glucose and other therapeutic foods. In 2015 Saving Moses Founder, Sarah Bowling, spoke at several events which raised much needed funds to support Saving Moses' mission
