	Our Overdose Prevention program, under the medical direction of Dr Paul Satterlee, has built partnerships with hospitals, first responders, treatment and sober living facilities, and citizens to provide the lifesaving, overdose-reversal medication naloxone and to expand knowledge of the limited immunity provisions of Steve's Law We distributed over 1300 Overdose Rescue Kits and trained over 1000 professionals and laypeople in how to reverse an opioid overdose Many of these people were trained to become trainers themselves, thereby expanding the reach of this important life-saving knowledge Importantly, we also worked to ensure access to evidence-based addiction treatment following an overdose Our program is a model for states across the country and we willingly share our strategies with other states in need of guidance We received 800 boxes of Evzio auto-injector naloxone (2 auto-injectors per box) which we distributed at no charge throughout the community as part of our Overdose Rescue Kits to help ensure access to naloxone for those at risk of overdose These boxes were valued at \$490 per box for a total of \$392,000 based upon the wholesale value of the medication as provided by the manufacturer

	Our Advocacy program celebrated success on both the federal and state levels We sponsored and supported the FEDUPI Coalition's call for federal action to end the opioid epidemic by providing leadership for the October FEDUPI Rally and March to the White House in Washington D C About 3,000 people rallied to hear expert testimony about the opioid epidemic and to memorialize loved ones who have been lost to the epidemic We coordinated a nationwide effort to obtain the release of the much-needed CDC (Centers for Disease Control) Guideline for Prescribing Opioids for Chronic Pain We successfully lobbied for the passage of a \$290,000 appropriation to support first responders in implementing Minnesota's Good Samaritan and Naloxone legislation (Steve's Law) Our staff and volunteers developed coalitions and partnerships to increase the impact of our lobbying and advocacy We held events, and participated in events sponsored by partner organizations, that increased public awareness of the dilemma of chronic pain and the disease of addiction Expenses shown are exclusive of \$37,513 of donated legal and other services related to this program

	Our Prescriber Education program, under the medical direction of Dr Charles Reznikoff and in partnership with the Minnesota Medical Association (MMA) and the University of Minnesota Medical School, has created free Continuing Medical Education (CME) through its lecture series on Pain, Opioids, and Addiction Experts in these fields have presented lectures to the medical students which are then filmed, edited and posted on the website of the MMA at http://www.mnmed.org/advocacy/Key-Issues/prescription-opioids-lecture-series as free, enduring CME available to practicing physicians and other prescribers across the country The lectures provide education on a variety of topics related to the responsible use of opioids and pain management education that is still lacking in most medical schools across the country We have created a curriculum that is balanced, practical, evidence-based, and free of commercial bias 13 courses are currently offered, and these are being utilized to provide much-needed guidance to medical professionals The expenses shown are exclusive of \$2,100 of donated professional services
