NicaPhoto's after school program serves approximately 100 children and young people living in some of the poorest barrios in Nicaragua. The goal of the program is to provide the proper supports to increase school graduation rates. The program is holistic in nature and focused on education, art, and personal development. The program includes academic assistance and reinforcement; a youth run, bio-intensive, organic garden; a healthy hot lunch (as hunger and malnutrition are common issues amongst our children); sports, chorus, photography, and dance; girls and boys groups run by a staff psychologist; and a partnership with Level Up Village to provide S.T.E.A.M. based classes connecting with US students.
