

**Form 990-EZ, Part III, Line 28, Program Service Accomplishments:**

The organization has been successful in achieving its above mission with many initiatives undertaken throughout the year. The organization hosted The Techniques for Success (TFS) conference for educators, administrators, therapists and parents to learn best practices to teach students with Down syndrome and other special needs. A new format this year allowed for breakout sessions so people could listen to the topics most applicable to their child's needs. This conference has received rave reviews from parents, Montgomery County Public School and Archdiocese of Washington Schools. DSNMC hosts social engagements for parents and families of those who have been touched by Down syndrome (winter dance, spring picnic, summer pool party, playdates and Tools for School parent workshops). DSNMC has an active listserv so parents can connect, ask questions and share resources. DSNMC fosters advocacy by having a large group attend the Buddy on Washington each year to have members meet with elected officials to discuss topics of importance to our community. Our outreach to Spanish speaking families has continued to grow and we hold bi-monthly meetings for those families in addition to including them in all regular activities. We engage our older self-advocates with a series of public speaking and social interaction workshops in conjunction with Artstream where they work with peer mentors to learn how to handle social situations and become more confident speakers.
