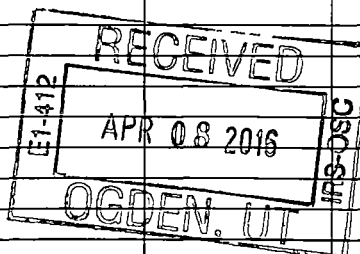

Summary of Direct Charitable Activities

The following summarizes what the Merrill Schneider Foundation (MSF) accomplished with 501(c)(3) public charities in 2015. The only expense with respect to these activities was the salary paid to the staff person working on these activities. That salary is report on Part I, line 14.

1. The Life You Can Save: This US based NGO has a mission to end extreme poverty on the planet. After doing a preliminary needs assessment with the Executive Director it was determined that the MSF will provide executive coaching to the ED and pilot a project in Portland to increase Ethical Philanthropy in Portland that is focused on eliminating global poverty. Towards this end MSF's staff person began immersing himself in the current research and trends regarding extreme poverty and philanthropy
2. New Avenues for Youth: This 18 year old agency in Portland is organized to provide homeless and at-risk youth with the resources and skills needed to lead healthy, productive lives. MSF focused most of its direct services on supporting this Agency in fulfilling its mission. On a weekly basis two of the Senior Managers (Administration/Finance Director and Development Director) received one on one executive coaching and consulting. In addition the MSF developed and delivered productivity workshops that all 17 Managers participated in. The other main thrust of our activity with this organization was the redesign of the entire volunteer program. Lastly MSF also offers coaching to staff who are looking for a boost in their performance. Statements from two of the Senior Managers are attached
3. Chabad Northeast Portland: Chabad Northeast is designed to have all Jewish people in Northeast Portland be connected to their souls. The MSF worked with the Rabbi leading this fledgling organization and assisted him on a weekly basis in accomplishing the following: Having a Mission, Fundraising Goals, Strategic Planning and having a stable infrastructure. Chabad Northeast is now on its way toward operating viably on a sound financial foundation and increasing the number of people that it serves.
4. Neighborhood House: Neighborhood House has been providing social services in Portland for over 100 years. It primarily serves recent immigrants, seniors as well as Portland Public School youth who may fall between the service cracks. The MSF had a short term engagement here to identify what was not working with its Senior Services Program.

Question 3 – Prior to 2015, the Merrill Schneider Foundation (MSF) was only making contributions to 501(c)(3) public charities. 2015 was the year the MSF formulated its Mission, hired a part time paid staff person and began making a difference both locally and internationally. The paid staff person – a local management consultant and business coach working well below his usual compensation rate – worked with the foundation on its mission and service delivery model. The Foundation, in addition to contributing financially to 501(c)(3) public charities, is now providing direct hands on support to several diverse 501(c)(3) public charities. The only recipient of Part I, line 14 salaries was the paid staff person. He was only paid for work with respect to direct charitable activities and was not paid for any administrative work for the foundation. The founder of the foundation also participated in the providing of direct charitable activities though his participation was more limited than that of the paid staff person.
