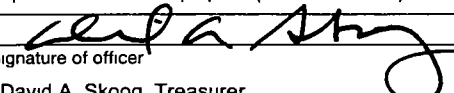

All donations range from \$250 to \$1,000 per cause. Ten of the causes were specific assistance to individuals: six distributions to assist medical patients with their medical or other expenses, three distributions to assist children in families whose breadwinner had died, and one distribution to an individual whose home was destroyed in a fire.
