

Expenses related to inspiring dancers to uniting dance and service through a network of university chapters, international dance exchanges, and year-round dance programs in underserved communities: insurance (\$3370), supplies (\$2937), lodging and meals (\$29752), dance education and development (\$9336), banking and platform fees (\$728), website (\$433), transport (\$15842), and other related expenses(\$3673).

Accomplishments in 2015 include a successful pilot program to India that supported one year of free dance education for youth from The Society for the Education of the Crippled in Mumbai and Ek Prayaas School for the Underserved in Kolkata. Dance diplomats from the United States participated in an inaugural exchange and taught daily dance classes for 100+ youth in underserved communities in and Kolkata in addition to collaboration with dance professionals from DNA Danceworks and Summet Nagdev Dance Arts.

Panama programming expanded from year-round, locally staffed free dance education at three orphanages to include youth from two public schools in the rural communities of Meteti and Tierra Prometida which did not previously have formalized dance training. Move-Ex employs five Panamanian dance instructors who teach approximately 300 dance classes per year at these five locations.

Since Move-Ex's inception, over 12,00 youth in Panama have received dance classes through year-round dance instruction with local teachers and through international dance exchanges hosting volunteer U.S. dance diplomats. 270 dance diplomats from the U.S. have volunteered internationally through Move-Ex to date.

21 Move-Ex University Chapters throughout the U.S. spent 3700 hours volunteering in their own domestic communities in 2015. Chapters provide dance education at no cost to a variety of organizations including domestic violence shelters, youth foundations, refugee centers, and public schools. This past year, University of Utah, Middlebury, Florida State, Indiana University, Butler, UC Irvine, Purdue, among others participated on international dance exchanges. Move-Ex was featured in the documentary "Youth in Movement" directed by Blair Brown.
