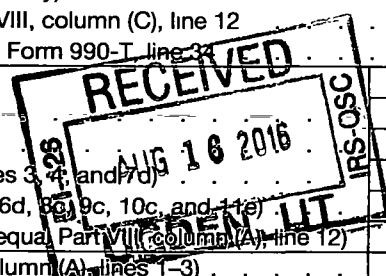

**Open Source Software Development (SD):**  
Mifos X is a free and open source financial software developed to build the complete range of financial services required for effective financial inclusion. The reference apps are examples of how to build microcredit and microsavings applications using Mifos X. In 2015, the core team led ongoing development of the Mifos X software platform and successfully guided the technical the technical contributions from external partners and volunteers. Collectively, the community released multiple new versions including self-service APIs, a progress out of poverty measurement tool, more savings functionality and variable rate loan and savings capability.

4b (Code: Comm) (Expenses \$ 121,002.05 including grants of \$ 0) (Revenue \$ 761.84)  
**Community Development (Comm):**  
The global Mifos community is made up of financial institutions, local technology partners, and volunteers who use, support, and volunteers who use, support, and develop the software respectively. We provide the tools, framework, governance, and infrastructure for global collaboration and conduct outreach to reach new users, recruit new partners, and attract new volunteers. Small financial institutions serve the poor in the developing world. We started 2015 with 115 financial institutions. By year end of 2015, we had 186 Mifos installations reaching a total poor client base of 3.6 million clients around the globe. We grew our client base by broadening software functionality, increasing deployability and increasing the total number of deployment partners. We grew to 53 deployment partners plus 20 innovators building solutions on the Mifos X platform - all with the social mission of lifting people out of poverty.

**Education (Edu):**  
To promote our mission and recruit volunteers, we attended OSCON, LinuxFest, World Council of Credit Union Meeting, SOCAP, Global WA, and hosted a Mifos Users meeting. We continue to enhance our web based user manual, developed a series of training videos, continue to host a monthly user check in. One of the largest initiatives in education and training was to translate our documentation and demo system into Spanish to support our Latin American efforts.
