



affecting Montana's native communities. Throughout the year, we engaged with students and leaders in the tribal colleges, tribal
government, and other Native organizations to educate Native citizens on the importance of civic engagement at all levels. We also
provided information to our members on the public policy process and how to interact effectively with decision makers.

Part III, Line 29: We advocated for a variety of public policies that directly impact Native American communities in Montana. During the
legislative session, we provided testimony in favor of expanding Medicaid coverage as provided under the Affordable Care Act. We
worked for a variety of education related legislation, including preservation of native culture and languages, expanded funding for tribal
colleges and high schools, enacting anti-bullying legislation for all Montana schools, and increasing the legal drop-out age to 18. We
worked with officials across Montana to establish satellite voting stations on several Montana reservations to decrease participation barriers
for eligible, and often disenfranchised voters in those communities, we also worked to have tribal identification included as a recognized
form of identification for online voter registration. We advocated against requiring all Montanans to vote by mail because mail delivery on
many reservations is problematic.

We also hosted leadership development opportunities for our staff as well as Native American leaders and students.
