We provide a safe-haven for the holistic rehabilitation and adoption of abused, abandoned and neglected horses Over the past 4 years, we have rehabilitated and placed into new homes over 35 horses As of the end of 2015, we have 5 horses in our rehabilitation program

Through our training and educational programs, we help people develop healthy partnerships with horses Since 2013, we have offered a unique horsemanship program for veteran families who want to learn how to care for and work with our rehab horses - this program offers mutual healing benefits to both the horses and the military families Many more volunteers from the community also get involved in helping us with the horses and our veterans program

During times of crisis, we partner with other nonprofits and individuals throughout the US to provide resources for people and horses that are in harm's way The Bastrop fires of 2011 were the genesis of forming our nonprofit Since then our volunteers have helped provide resources during the Austin floods of 2013 and collaborated with other nonprofit organizations to meet immediate community needs
