From its inception, the Fund has generated approximately \$75 million in contributions and pledges in support of a variety of charitable and educational initiatives in the City of Chicago The vast majority of these contributions and pledges have, through the efforts of the Fund, been made to local donor advised funds and charities, although some have been made directly to the Fund itself The Fund is not compensated for its fundraising efforts on behalf of these donor advised funds and charities The Fund has focused its fundraising and grant making activities on the priority areas of public safety, arts and culture, open space, and education Selected highlights within those priority areas include the following Public safety - The Fund's early efforts led to the successful raising of almost \$50 million to support public safety initiates in the City of Chicago Arts and culture - The fund has assumed the lead role in securing philanthropic support for the Chicago Architecture Biennial, a first-of-its-kind international forum on architecture and the designed environment held in Chicago in 2015 The fund has raised approximately \$6 million in support for the Biennial The Fund also raised \$1 million in charitable support for a public festival along the Chicago rver Open Space - The Fund secured \$20 million in donations and pledges to the Maggie Daley Park fund (A Donor advised fund at a local charity) to be used to assist in the building and completion of Maggie Daley Park, a project of the Chicago Park District The Dynamic, sustainable, multi-functional 20-acre park reaches out to the local neighborhood as well as the larger Chicago community and visitor population
