Brigance that aired numerous times on ESPN during the Baltimore Ravens Super Bowl run. The Foundation has also provided grant support to a number of families to help and assist with their request to enhance their family members quality of life. Among those receiving grants from the Foundation resulted in a donation of a wheelchair; the purchase of a DynaVox communication device which now allows the ALS family member to continue to communicate with her family and friends; and funding to support in-home health care so a family can gain back some financial stability
