Omidyar Fellows - The Omidyar Fellows is a leadership development program for emerging leaders in the state of Hawaii. In 2015 the third cohort completed the curriculum phase and the fourth cohort was recruited and began the process. The 15 month long program begins with selection in August, starting in September and concluding with commencement in November of each year. The Omidyar Fellows followed a curriculum and program that developed transformative leadership on individual, group and community levels, using program elements that include executive coaching, peer and cohort learning, leadership conversations and an out-of-state learning excursion. The Fellows continue post commencement as transformative leaders in service to solve the most significant problems facing Hawaii.

Community Leadership Development - Sponsoring public talks and speaker series on contemporary issues that will influence and impact more effective leadership. Providing national speakers (such as Sheila Heen from the Program on Negotiation at Harvard) to the local leadership community including for-profit, nonprofit, academic and governmental leaders.
