RESPIRE PARTNERSHIP COLLABORATIVE THE RESPIRE PARTNERSHIP COLLABORATIVE (RPC) WAS A PUBLIC-PRIVATE PARTNERSHIP OF THE COUNTY OF SACRAMENTO, DIVISION OF BEHAVIORAL HEALTH SERVICES, THE CENTER AND THE COMMUNITY AT LARGE. THE GOAL OF THE RPC WAS TO INCREASE LOCAL MENTAL HEALTH RESPIRE SERVICE OPTIONS BY OFFERING ALTERNATIVES TO HOSPITALIZATION FOR COMMUNITY MEMBERS EXPERIENCING A CRISIS IN SACRAMENTO COUNTY. THE RPC WAS FUNDED THROUGH THE MENTAL HEALTH SERVICES ACT (MHSA) INNOVATION COMPONENT. INNOVATION IS ONE OF FIVE COMPONENTS WITHIN THE MHSA AND HAS THE SOLE OBJECTIVE OF ALLOWING COUNTIES THE OPPORTUNITY TO TRY NEW APPROACHES TO LEARN MORE ABOUT WHAT MAY WORK TO INCREASE ACCESS FOR UNDERSERVED GROUPS, INCREASE QUALITY OF SERVICES, PROMOTE INTERAGENCY COLLABORATION AND/OR INCREASE ACCESS TO SERVICES. THE RPC HAS DISTRIBUTED GRANT FUNDS TO 10 ORGANIZATIONS TO SUPPORT THE DELIVERY OF MENTAL HEALTH RESPIRE TO OVER 5,000 CONSUMERS, FAMILIES AND CAREGIVERS AT RISK OF EXPERIENCING MENTAL HEALTH CRISIS IN SACRAMENTO COUNTY.
