DURING 2015, THE PAC FOCUSED ON BUILDING OUT THE DESIGN TEAM FOR THE PAC BUILDING. THE PAC SELECTED REX ARCHITECTURE AS DESIGN ARCHITECT. REX WAS SELECTED THROUGH A RIGOROUS INVITATION PROCESS FOCUSING ON ARCHITECTURAL FIRMS THAT HAD PREVIOUSLY DESIGNED CELEBRATED PERFORMING ARTS HOUSES. THE THREE FINALISTS WERE HENNING LARSEN (DENMARK), UNSTUDIO (THE NETHERLANDS), AND REX (UNITED STATES). REX IS AN INTERNATIONALLY ACCLAIMED ARCHITECTURE AND DESIGN FIRM IN BROOKLYN, NEW YORK. SEMINAL PROJECTS INCLUDE THE DEE AND CHARLES WYLY THEATRE IN DALLAS, TEXAS, THE VAKKO FASHION CENTER AND POSER MEDIA CENTER IN ISTANBUL, TURKEY, AND THE SEATTLE CENTRAL LIBRARY. REX IS LED BY JOSHUA PRINCE-RAMUS WHO WAS THE FOUNDING PARTNER AND PRINCIPAL OF OMA NEW YORK, UNTIL HE REBRANDED THE FIRM AS REX IN 2006. THE PAC ALSO SELECTED DAVID BRODY BOND AS EXECUTIVE ARCHITECT. DAVID BRODY BOND, FOUNDED IN NEW YORK IN 1952, IS ACCLAIMED FOR THEIR WORK IN UNIVERSITIES, HOUSING, CORPORATE OFFICES, INDUSTRIAL AND INSTITUTIONAL BUILDINGS. MORE NOTED PROJECTS INCLUDE AN ADDITION AND RESTORATION OF THE NEW YORK PUBLIC LIBRARY, RESEARCH FACILITIES FOR COLOMBIA AND PRINCETON UNIVERSITIES, AND THE NATIONAL SEPTEMBER 11 MEMORIAL AND MUSEUM AT THE WORLD TRADE CENTER. LASTLY, THE PAC SELECTED CHARCOALBLUE AS THEATER DESIGN CONSULTANT. CHARCOALBLUE WAS FOUNDED IN 2004 IN LONDON, HAVING SINCE GROWN TO INCLUDE THREE ADDITIONAL STUDIOS IN BRISTOL, ENGLAND, NEW YORK CITY AND MELBOURNE, AUSTRALIA. CHARCOALBLUE HAS BECOME THE THEATER CONSULTANT OF CHOICE FOR MANY OF THE WORLD'S LEADING ARCHITECTS AND THEATER COMPANIES. THEIR WORK INCLUDES WORLD-FAMOUS COMPANIES LIKE THE ROYAL SHAKESPEARE COMPANY, THE ROYAL NATIONAL THEATRE AND GLYNDEBOURNE FESTIVAL OPERA TO CUTTING EDGE OUTFITS SUCH AS SIOBHAN DAVIES DANCE, GRAEAE AND ST. ANN'S WAREHOUSE IN BROOKLYN, NEW YORK. THE PAC ENGAGED A PORTION OF THE DESIGN TEAM TO PERFORM A DESIGN STUDY FOR THE PAC'S PUBLIC FUNDERS. AS THE STUDY ACHIEVED ITS GOALS, THE PAC'S PUBLIC FUNDERS APPROVED \$10 MILLION OF FUNDING TOWARD THE PAC DESIGN TO BEGIN IN EARLY 2016.
