EDUCATION (Empowering Children) - Over 425 children from preschool to Class 8 received top quality, English medium education through our Shining Light Academy located in Gilgit, Pakistan. Approximately 25% of our students were from the Christian minority community that attended SLA on a scholarship basis. Our Scholarship Program enabled over 100 minority Christian children to attend local schools, including Shining Light Academy, from preschool through college that otherwise would not receive an education. This has resulted in well over a dozen Christian families that are no longer living in poverty, have built their own homes and have ended the curse of poverty for future generations. Additional accomplishments include: a) Science Center - SLI raised \$15,000 to construct, equip and furnish a science lab that will accommodate middle school and high school students. Construction will begin in spring of 2016. b) Teachers - Our SLA teaching staff has increased to 40 with the addition of a new Early Childhood Development (Pre-School) building scheduled to open in the spring of 2016. Due to the difficulty of recruiting experienced Christian teachers from Central Pakistan, a new recruiting drive resulted in the acquisition of experienced teachers from the local community. All of our ECD teachers (10) received special training in Islamabad in the winter.

2) TRAINING (Empowering Women) - By the end of 2015, over 375 women had received sewing, cutting, knitting, embroidery and wool weaving skills through our Women's Vocational Training Center (WVTC) in Gilgit, Pakistan. The WVTC is a key component of our Women's Empowerment Program that provides job/life skills training, Urdu literacy, business entrepreneurship training & gender equality awareness for mostly low income women from the local community. Over 10 women have been employed full time through our Life Stitch Manufacturing Center through the production of women's clothing, accessory and handcraft items that have been exported to the USA. These items generated sales revenue of \$26,000 in the second year of operation (more than double last year) with plans to expand sales throughout the US, Pakistan and locally with additional products. SLI is partnering with the University of Alabama's STEM (Science, Technology, Engineering & Math) Program for MBA students. The STEM students have formed 4 teams to support and assist Life Stitch development in the following areas; 1) business process development, 2) marketing & advertising, 3) online catalogue website development and 4) new product development.

3) DEVELOPMENT (Empowering Communities) - The Rural Village Development Program (RVDP) was established to provide quality education to remote, isolated communities in northern Pakistan. One of the most oppressed and marginalized groups are the semi-nomadic Gujjars. They are a poor, illiterate and oppressed people that live in the high mountain valleys in Gilgit-Baltistan. Because of religious extremism, the Gujjars in Gilgit-Baltistan had not been educating girls until recently. Since 2007, Shining Light has been providing school equipment & supplies, hiring local teachers and paying for student school fees, books and uniforms. Mobile tents have been erected and teachers have been hired so Gujjar children can go to school during the summer months while grazing their animals in the high mountain pastures. To date, Shining Light has equipped 4 remote village schools, hired 9 local teachers and enrolled over 600 children that are receiving a free education. Over 150 Gujjar girls are receiving an education for the first time! Just over \$35,000 was raised for the following projects in 2015: a) Gujjar Mother Tongue Literacy Program - In partnership with a local organization working with the Gujjar people, SLI successfully launched a Gujjar Mother Tongue Literacy program that is fully endorsed and approved by village elders. The program will develop reading primers for preschool to class 1 Gujjar children

Shining Light International was founded in the USA in 2012 to support and partner with SLCDO. The \$80,800 given to SLCDO was used for numerous projects all in accordance with Shining Light International's mission statement. The assistance was used for scholarships for students, education in remote villages, development of primers, construction of a science lab and women's training.

c) **Scholarship Program:** This year we extended our scholarship program to provide scholarships for college & university students and special higher education support for our Pakistan employees. Just over \$30,000 was allocated for the following scholarship programs:

i) **Primary Education –** Preschool through high school Christian students received \$12,000 for tuition, books, uniforms and other expenses.

More than half of the recipients attend Shining Light Academy.

ii) **Secondary Education –** Six Christian students (4 women) received \$11,000 for college tuition, fees, books and personal expenses. These are the first Christian students to attend college in Gilgit, Pakistan and in the history of their families. . . Several are volunteering at SLA with plans to become employed teachers or administrators upon graduation.

iii) **Tertiary (Higher) Education –** One Pakistan employee received \$7,300 for the first year of a 2-year Master's program at Forman Christian College in Lahore, Pakistan with plans to return to Shining Light upon graduation. We believe providing higher education opportunities for our employees will be mutually beneficial by increasing the skills, knowledge & loyalty of our professional staff.

d) **New ECD Building –** Due to the high demand from the local community for ECD (Preschool) education, a new ECD building with over 8 classrooms was constructed, equipped and furnished including a large playground. The building opened in the spring of 2016 with a much larger enrollment than before. Increased capacity will allow SLA to become sustainable within one year.

that will have the following benefits: 1) teach children how to read and write their own language (Gojri is an unwritten language), 2) aid in quick acquisition of Urdu (the national language of Pakistan) and 3) provide introduction to conceptual learning (rote memorization is the standard education methodology). Select local Gujjar teachers have been trained to read, write and develop primers specific to the regional dialect. These teachers have completed the first set of primers for Preschool children that was printed and distributed to 3 Gujjar schools by the start of the school year in March 2015.

b) **Gujjar Mobile (Tent) School –** Two tent schools were purchased, erected and equipped in one mountain valley to provide education education through the summer months to Gujjar children living in the high pastures. A school teacher was also hired and supplied with food. This has been a very successful program to meet the unique and specific education needs of our Gujjar children.

c) **Invest in Them Campaign –** SLI raised nearly \$2,000 to provide education to Gujjar boys and girls through our Invest in Them Campaign.

Specific emphasis has been placed on educating girls as they are the most vulnerable in this male dominated society.

d) Home Parties & Sales Events – 53 home parties were organized in the US to sell infinity scarves produced by our Life Stitch Manufacturing Center. These parties along with a few other sales events generated \$14,000 that went directly to educating a girl in our RVD program. (It costs about \$150 to provide school fees, uniform, books and supplies for one girl to go to school for one year.)
