Field trips to allow students to broaden their horizons with a variety of activities such as the Kansas City Symphony, Discovery Center and Deanna Rose Children's Farm. Most students have had little exposure to such experiences.

Motivational Prizes and Snacks - Students earn points for their academic achievements and for arriving on time. With their points, they can buy prizes ranging from basic school supplies to a new bike. Students who save their points are rewarded with interest points while teaching them the value of saving and resisting immediate gratification. Healthy snacks, including fresh fruit, are served at each session, which teaches good eating habits and helps students focus on their work.
