The budgets for rhino translocations are agreed upfront and the costs disbursements managed against the agreed budget. In terms of the security and monitoring costs post release we have an agreed budget for the monitoring procedure which includes capital equipment, human resources and ongoing veterinary care of the animals. The project co-ordinator reports both the the Steering Committee of the Foundation and to the National Rhino Co-ordinator in Botswana as well as the Minister of Tourism and Wildlife Team.

Line 1 Line 2 Similarly in terms of the Ride For Lions program actual spend is monitored against a pre agreed and determined budget. In all instances third party suppliers are paid directly by GPF and all payments require valid authorised invoices in support.

PART 1 Line 3 1 Rhinos without Borders 0- the activities conducted in the region predominately relate to the security and monitoring of the rhinos post release and the management of the capture, quarantine and transportation operations once rhinos are identified for translocation. A small amount of fund raising is conducted in Botswana

Part 1 Line 3.1 Ride for Lions - this is a campaign to raise fundings to secure additional conservation land for lions and to raise funds to protect the big cat population from retaliatory poaching by the local communities by funding a predator compensation fund. This fund pay the local communities for livestock losses incurred due to wildlife attacks on their cattle and goat herds. The costs incurred to date relate to the event set up costs including marketing and preliminary route management.

In 2015 Linyanti Explorations held fund raising event for GPF and raised a net amount of \$19,977. Linyanti Explorations provide management and purchasing services for the security and monitoring of rhinos released into the Botswana wilderness. There is no charge for these services but all direct costs in relation to the project are charged to GPF and paid at cost.

Part IV Line 4 DR Joubert is the CEO of Great Plains Foundation and Great Plains Conservation as well as a director of Banoxi (Pty) Ltd. As a shareholder of Great Plains Conservation Ltd, Mr Joubert has an indirect holding of 20.25% of the issued shares of Banoxi (Pty) Ltd. The rhino monitoring staff have contracts of employment in the name of Banoxi (Pty) Ltd but the full cost of these employment contracts including statutory benefits accruing under Botswana employment legislation is charged to GPF and paid at cost.

Part IV Line 1 and 4 - Linyanti Explorations and Banoxi own and operate safari camps in Northern Botswana. As part of their marketing activities they have agreed to contribute a certain number of bed nights per annum to GPF to facilitate its fund raising activities. These beds are charged at a significant discount on the rack rate to GPF. The transaction values detailed above generated in excess of US\$400,000 in donations raised.
