The organization was created to (i) foster, promote and advance aviation, the physical or biological sciences, technology, engineering and mathematics (STEM) education by young people of all backgrounds, (ii) encourage interest and personal participation in aviation and related fields, and (iii) provide scholarships to middle school, high school and college aged youth of all backgrounds for the advancement of aviation and STEM learning, the pursuit of aviation-related interests and the pursuit of education in STEM studies at an accredited college, university or post-secondary school or aviation camp, academy, facility or technical school for educational instruction and educational camps in such areas

 AIM HIGHER IS THE ORGANIZATION'S FIRST CLASSROOM-BASED PROGRAM. IT IS A YEAR-LONG, IN-SCHOOL AVIATION SCIENCE COURSE. AIM HIGHER PROMOTES COMPELLING, AVIATION-FOCUSED STEM EDUCATION WITH THE GOAL OF HELPING ENGAGE STUDENTS IN SCHOOL, PARTICULARLY IN SCIENCE, TECHNOLOGY, ENGINEERING, AND MATH FIELDS. THE AIM HIGHER PROGRAM HAS BEEN IMPLEMENTED IN MIDDLE SCHOOLS IN TAOS, NEW MEXICO, SANFORD, FLORIDA, AND ORLANDO, FLORIDA. THE WINTER PARK HIGH SCHOOL IS ALSO INVOLVED IN THE PROGRAM AND INCLUDED AN ONLINE COMPONENT TO HELP STUDENTS PREPARE FOR AND PASS THE FAA PRIVATE PILOT WRITTEN EXAM. A TOTAL OF 70 STUDENTS AND 9 TEACHERS WERE INVOLVED AFTER SUCCESSFULLY COMPLETING THIS COURSE AND DEMONSTRATING GOOD ACHIEVEMENT AND BEHAVIOR, STUDENTS ARE ELIGIBLE FOR SCHOLARSHIPS TO ATTEND THE NATIONAL FLIGHT ACADEMY OR THE EXPERIMENTAL AIRCRAFT ASSOCIATION AIR ACADEMY IN MAY OF EACH YEAR. THE SCHOLARSHIPS INCLUDE TUITION TO THE NATIONAL FLIGHT ACADEMY OR THE EXPERIMENTAL AIRCRAFT ASSOCIATION AIR ACADEMY AS WELL AS THE STUDENT'S TRAVEL EXPENSES. THE STUDENTS LOCATED IN FLORIDA ATTEND A 3-DAY EXPERIENCE AT THE NATIONAL FLIGHT ACADEMY. THE STUDENTS LOCATED IN NEW MEXICO ATTEND A 4-DAY EXPERIENCE WITH THE EXPERIMENTAL AIRCRAFT ASSOCIATION.

 THE ORGANIZATION WORKED CLOSELY WITH THE EXPERIMENTAL AIRCRAFT ASSOCIATION AIR ACADEMY IN OSHKOSH, WISCONSIN TO DEVELOP A SCHOLARSHIP PROGRAM THAT PROVIDES TUITION FOR STUDENTS TO ATTEND THE AIR ACADEMY AS WELL AS TRANSPORTATION TO AND FROM THE AIR ACADEMY. THE FOCUS OF THE AIR ACADEMY IS TO UTILIZE THE MOTIVATION AND EXCITEMENT OF AVIATION TO ENGAGE STUDENTS IN STEM CONTENT. THESE CAMPS ARE HELD DURING AIRVENTURE, THE LARGEST ATTENDED FLY-IN IN THE WORLD DURING 2015, A TOTAL OF 8 FULL TUITION SCHOLARSHIPS INCLUDING AIR TRANSPORTATION WERE AWARDED TO STUDENTS TO ATTEND THE EAA AIR ACADEMY IN OSHKOSH, WISCONSIN. THE ORGANIZATION ALSO AWARDED A TWO MONTH PAID INTERNSHIP EXPERIENCE FOR TWO STUDENTS TO ATTEND THE EAA AIR ACADEMY. THE PAID STIPEND OF \$3,000 ALSO INCLUDED ROOM AND BOARD AT THE EAA AS WELL AS AIR TRANSPORTATION TO AND FROM OSHKOSH, WISCONSIN.
















 THE SCIENCE OF FLIGHT PROGRAM IS A HANDS-ON PROJECT BASED STEM LEARNING EXPERIENCE FOR UPPER ELEMENTARY STUDENTS. THIS PROGRAM INCLUDES A COMPREHENSIVE CURRICULUM WITH AN INTEGRATED PRE-POST TESTS AND RUBRIC EVALUATION SYSTEMS. AVIATION IS USED AS A THEME TO MOTIVATE STUDENTS. THE CURRICULUM ALSO INCLUDES AVIATION HISTORY AND QUALITY LITERATURE. THE CURRICULUM IS PRESENTED OVER A 6-WEEK PERIOD DURING A SCIENCE CLASS. IN ADDITION TO THE CURRICULUM, ALL MATERIALS NEEDED ARE INCLUDED IN A KIT FOR TEACHERS AND EACH STUDENT DURING 2015, THE ORGANIZATION WORKED WITH DALLAS INDEPENDENT SCHOOL DISTRICT IN SUPPORTING THE SCIENCE OF FLIGHT PROGRAM. THE ORGANIZATION ALSO BEGAN DEVELOPING THIS COMPREHENSIVE PROGRAM FOR THE GRAND PRAIRIE INDEPENDENT SCHOOL DISTRICT. IT IS ESTIMATED THAT OVER 1,000 STUDENTS, AS WELL AS CLASSROOM TEACHERS, WILL BENEFIT FROM THE CURRICULUM, KIT, AND PROFESSIONAL DEVELOPMENT. THE ORGANIZATION ALSO PROVIDED SUMMER SCHOLARSHIPS FOR STUDENTS TO ATTEND THE FRONTIERS OF FLIGHT MUSEUM SUMMER PROGRAMS IN DALLAS, TEXAS.
