The amount paid to Pat for services to both organizations includes \$114,629 in salary, \$6,781 in pension and \$17,680 in benefits. During 2015, Team Makers Club reimbursed the Executive Director for dependent care expenses that were incurred during work related overnight travel for Team Makers Club. The filing organization reported this income on a W-2.
