FOLLOWING A YEAR OF RESEARCH AND DEVELOPMENT, NORTHERN PLAINS EYE FOUNDATION(NPEF) LAUNCHED NORTHERN PLAINS EYE FOUNDATION WESTERN SOUTH DAKOTA LIONS CHILDREN'S VISION SCREENING INITIATIVE (CVSI) IN MAY OF 2012, WITH A GOAL OF MAKING VISION SCREENINGS ACCESSIBLE TO MORE CHILDREN, LEADING TO EARLY DETECTION, TIMELY DIAGNOSIS AND APPROPRIATE INTERVENTION THROUGH A UNIQUE PARTNER-SUPPORTED STRATEGY, NPEF AND LOCAL LIONS CLUB VOLUNTEERS TRAINED IN THE USE OF NEW SCREENING TECHNOLOGY, OFFER FREE CHILDREN'S VISION SCREENINGS AT DAYCARES, PRE-SCHOOLS AND ELEMENTARY SCHOOLS. COMPREHENSIVE SCREENING RESULTS ARE DOCUMENTED AND MAILED TO PARENTS OF CHILDREN SCREENED, WHICH INDICATE EITHER NO FOLLOW-UP IS REQUIRED, OR A COMPLETE EYE EXAM IS RECOMMENDED, AS (TEXT EXCEEDS SPACE ALLOWED - CARRIED OVER TO SCHEDULE O) WELL AS WHY THE CHILD IS BEING REFERRED TO AN EYE CARE PROFESSIONAL. IN THE CASE OF CHILDREN WHO REQUIRE A COMPLETE EYE EXAM, ADDITIONAL INFORMATION IS PROVIDED IN THE MAILING AS TO THE MEANING OF CONDITIONS IDENTIFIED ON THE SCREENING RESULT, EYE CARE PROFESSIONALS IN THE REGION AND AGENCIES THAT MAY PROVIDE ASSISTANCE TO FAMILIES IN NEED. WHEN THE CHILD RECEIVES AN EYE EXAM, AN EVALUATION FORM IS PROVIDED TO THE EYE CARE PROFESSIONAL, WHICH THE EYE CARE PROFESSIONAL IS ASKED TO COMPLETE AND RETURN TO NPEF. AS OF MAY 2015, AFTER ONLY THREE YEARS, NPEF HAS SCREENED 8,446 CHILDREN, 976 (12%) OF WHOM WERE RECOMMENDED FOR EYE EXAMINATIONS. LONG-TERM, OUR STRATEGY IS TO CONTINUE TO EXPAND CVSI SCREENINGS IN OUR REGION THROUGH PARTNERSHIPS WITH THE EYE CARE INDUSTRY, DONORS AND BUSINESSES IN ORDER TO SUSTAIN THIS IMPORTANT AND WORTHWHILE INITIATIVE. IN THE FALL OF 2014, NPEF WAS AFFORDED THE OPPORTUNITY TO ENGAGE A 4TH YEAR MEDICAL STUDENT AT THE UNIVERSITY OF SOUTH DAKOTA SANFORD SCHOOL OF MEDICINE AND A PARTNERING OPTOMETRIC INTERN FROM THE ILLINOIS COLLEGE OF OPTOMETRY IN A RESEARCH PROJECT RELATED TO NPEF'S CVSI. THE RESEARCH PROJECT CULMINATED IN THE PUBLICATION OF A MANUSCRIPT ENTITLED, "RESULTS OF A PEDIATRIC VISION SCREENING PROGRAM IN WESTERN SOUTH DAKOTA" IN THE MARCH 2015 EDITION OF SOUTH DAKOTA MEDICINE, THE SOUTH DAKOTA STATE MEDICAL ASSOCIATION MEDICAL JOURNAL. SINCE THAT TIME, NPEF CONTINUES TO ENGAGE WITH 4TH YEAR MEDICAL STUDENTS AT THE UNIVERSITY OF SOUTH DAKOTA SANFORD SCHOOL OF MEDICINE IN ONGOING VOLUNTEER RESEARCH PROJECTS RELATED TO CVSI.

CHRISTMAS GIFT OF SIGHT, A CHARITABLE PROGRAM LAUNCHED IN 2008, AWARDS SIGHT-SAVING SURGERY TO INDIVIDUALS WITHOUT THE FINANCIAL MEANS TO AFFORD THE NECESSARY CARE. IN 2015, NPEF EXPANDED ITS CHRISTMAS GIFT OF SIGHT PROGRAM FROM ANNUAL TO SEMI-ANNUAL SURGERY AWARDS. SINCE ITS INCEPTION, NPEF HAS PROVIDED OVER 30 SIGHT-SAVING SURGERIES THROUGH CHRISTMAS GIFT OF SIGHT, HELPING THOSE UNDERSERVED IN OUR COMMUNITY REGAIN THEIR VISION, AND MOST IMPORTANTLY, INDEPENDENCE, MOBILITY AND QUALITY OF LIFE.

NPEF'S HEALTH-CARE EDUCATION SCHOLARSHIP PROGRAM WAS DEVELOPED IN 2005 IN RECOGNITION OF THE NEED FOR FUTURE HEALTH AND EYE CARE PROFESSIONALS IN OUR REGION. SCHOLARSHIPS WERE INITIALLY AWARDED TO UNDERGRADUATE STUDENTS PURSUING FULL-TIME HEALTH-CARE RELATED STUDIES. FOLLOWING A PROGRAM EVALUATION IN 2012, NPEF MADE A DECISION TO CHANGE THE FORMAT OF THE SCHOLARSHIP PROGRAM FROM GENERAL HEALTH CARE TO A FORMAT FOCUSED MORE DIRECTLY ON IMPACTING THE GROWING NEED FOR EYE CARE PROFESSIONALS. BEGINNING IN 2013, THROUGH AN AGREEMENT WITH THE UNIVERSITY OF SOUTH DAKOTA FOUNDATION, NPEF PLEDGED TO (TEXT EXCEEDS SPACE ALLOWED - CARRIED OVER TO SCHEDULE O) GIVE 7,500 IN SCHOLARSHIP AWARDS (1,500/SCHOLARSHIP/YEAR) TO FOURTH YEAR STUDENTS WITH AN EXPRESSED INTEREST IN OPHTHALMOLOGY OR OPTOMETRY, WHO HAVE BEEN ACCEPTED INTO THE UNIVERSITY OF SOUTH DAKOTA SANFORD SCHOOL OF MEDICINE. THE SCHOLARSHIP, NAMED THE NORTHERN PLAINS EYE FOUNDATION DR. PAUL L. ZIMMERMAN MEMORIAL SCHOLARSHIP, IS AWARDED TO A RECIPIENT FROM NPEF'S SERVICE AREA, WHICH INCLUDES SOUTH DAKOTA, AND PARTS OF NORTH DAKOTA, NEBRASKA, WYOMING AND MONTANA. SINCE THE PROGRAM'S 2005 INCEPTION, NPEF HAS AWARDED FIFTY-THREE SCHOLARSHIPS TOTALING 77,500 TO RECIPIENTS IN ITS 5-STATE SERVICE AREA.
