In addition, fatherhood education, job training and on-going case management. Clients consist of young women in unexpected pregnancies who are choosing to carry to term or place for adoption. An estimated 2000 clients are assisted through the program during the year. The Alliance provides the acquisition of the contract and then manages and monitors the program funds and services provided by the sub-contractor.
