THE IMR TEAM HELD MEDICAL CLINICS INCLUDING GENERAL MEDICAL PATIENT EVALUATIONS, SPECIAL CARE CONSULTATIONS, WELL PATIENT EXAMINATIONS, URGENT CARE, PHARMACY AND COMMUNITY HEALTH TRAINING.
