EX-OFFENDERSServing California is addressing our state's staggering 54% recidivism rate for inmates who re-offend after being paroled back into our communities within three years of release, by facilitating programs to change these behaviors. The Urban Ministry Institute (TUMI) has now been offered to over 1,474 inmates in California prisons since the beginning of the program, with 777 of those being involved in 2015. A 3-5 year Biblical-based education and personal character reformation program, our students' recidivism rates are a low 6.0%. AWANA Programs are offered in Los Angeles County Jails. Malachi Dads and Hannah's Gift Bible Studies, which include teaching inmates to be better parents, saw more than 2,800 inmates participate during the year.

VETERANS OUTREACHServing California proudly supports Mighty Oaks Warrior Programs at SkyRose Ranch and their commitment to mending the brokenhearted of our Nation with a specific calling to assist America's active duty service members, veterans and their families. The Mighty Oaks Warrior programs address Combat Trauma, Character, and Support for "Combat Trauma" spouses and family members with training in reintegration skills through instruction at our rehabilitative ranch in San Miguel, California. With 22 veteran suicides per day nationwide, we are proud that ZERO% of our alumni have fallen victim to this statistic.

Programs we sponsor also include assisting women upon completion of sober living programs, offering continuing education opportunities, as well as life skills and job placement training.
