Each year, the ?I Careyes Foundation invites a series of national and international visual artists for a residency that generally lasts one month including studio workspace and materials The program focuses on collaborations with local schools to produce workshops with children The program is essential to the cultural exchange the foundation promotes Additionally, artists have the option of staging an exhibition, discussion, performance, or screening for the community, allowing diffusion of the foundation's programs around the world In 2015, the program and exhibition of Conrad Shawcross stayed until February while In June the art residency of Scoli Acosta started 50 children participated in the workshop The foundation was unable to invite additional artists in 2015 due to Hurricane Patricia In addition to the expenses being reported in Part IX of this return, there were in-kind gifts of \$31,662

For more than 33 years, the Careyes community has worked to protect sea turtles nesting in the area In 1983, only 11 turtles were laying eggs in the region By 2015, 1,275,000 sea turtles of 4 species have hatched on Careyes beaches and made it safely to the ocean ?I Careyes Foundation is supporting this effort A team of four watchmen patrolled the Careyes beaches all year round to ensure the protection of turtles and hatching of eggs from predators In 2015, 1,773 turtles nested and more than 125,000 turtles hatched and made it to the sea In addition to the expenses being reported in Part IX of this return, there were in-kind gifts of \$45,725 The sea turtle program required additional expenditures in 2015 due to the reconstruction of the hatching facilities after Hurricane Patricia (continue on Sch O) A special keeper in Playa Tapeixte was hired for 5 months directly by the Foundation to camp and guard the beach with more Hawkbill's nests and hatchling In March and April, the foundation put up together an exhibition on the turtles and photos of Petr Myska about the fauna and flora of the area This exhibition was in line with the ecology mission of the foundation and will be used again in the future

The ?I Careyes Foundation laid the groundwork to offer a new educational program to the local rural communities which is an English program The foundation produced a custom made English-Spanish book, tailored specifically to the educational needs of the children of primary schools in rural areas This will provide them with the necessary tools to become productive and successful members of the community Living in an area where the biggest source of employment comes from tourism, it is essential for young generations to become bilingual With the help of volunteers, the lessons started in January 2015 in 9 rural schools In November 2015, the program was fully integrated into 11 schools In parallel, under the supervision of a professional player, we created a sports program, having as a goal to promote an active lifestyle and to develop values like discipline, perseverance and teamwork The first bike polo school was inaugurated in August 2014, and we opened a second school in July 2015 Between the two schools, there are now 67 children participating in the program In addition to the expenses being reported in Part IX of this return, there were no in-kind gifts
