Yang arts & sciences foundation aims to improve the culture exchange between USA and China. Guizhen Yang the chairman of the foundation, visited several cities in China to investigate the youth education in China. Based on the findings from these trips, Yang arts & sciences foundation worked with Dreams Corps (website [www.dreamcorps.org](http://www.dreamcorps.org)), a public non-profit organization on the efforts to build libraries in schools in China.

Yang arts & sciences foundation provided financial support to facilitate the efforts of Dreams Corps to build libraries across the schools in many cities in China. Dream Corps Summer Volunteer Program (SVP) Beijing Training Camp has successfully concluded on May 24th, 2015. In the year of 2015, 42 volunteers with various backgrounds and 20 site school teachers and principals have gathered and participated in a 3-day training camp. During training, teachers, school principals, and volunteers have done various team-building activities, seminars, and workshops. Through training, they have developed a solid understanding of Dream Corps' mission and vision, how to facilitate reading activities, as well as the skills of setting up a library from scratch. In the year of 2016, Dream Corps has continued their efforts in building an effective library system in rural areas in China.

We also supported local libraries such as King County Library System at Bellevue, WA.
