Grace Missions provides spiritual, operational, and financial support for Grace School in Koro, Mali, which provides Christian based primary education in an impoverished area of a very poor country. Grace Missions has helped build a new school building educating over 100 local children, supplied much of the operating budget, provided jobs for teachers and construction workers, and brought hope to many families who otherwise would not have been able to send their children to a quality school. Future plans for Grace Missions include completion of the 2nd and 3rd sets of primary school classrooms, more vocational and technical training, a school nurse, and the eventual creation of a high school.
