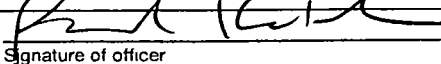

The Sunrise Center is a 12,500 sq ft building in the heart of Rockwood. We leased it with an option to buy. We have used the Sunrise Center as a community center. Activities that occurred there are those that we believe help build community strength. They include, but are not limited to: cultural dance classes for children of Latino heritage; free hot food distribution to homeless people; City Council-led public meetings; offices for a group that serves recently incarcerated adults; substance abuse recovery classes; church services; a commissary kitchen that supports economic development by hosting new entrepreneurs; parties; and, civic meetings.

Rockwood English Language Institute (RELI) is a program for adults who do not speak and/or read/write English. In 2015, we launched a pilot program to determine the feasibility of creating RELI. The program was deemed a success because 68 adults were served, and over 70% of them graduated to the next instructional level.

Immigrant and Refugee services are a collection of services that we provided to immigrants and refugees in Rockwood. These included, but were not limited to: Homework Club that served over 50 children with after-school tutoring; and, Summer Programs that served over 150 children with outdoor activities.
