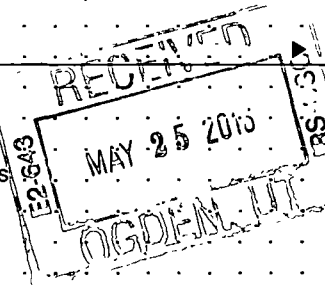



Part III Program Accomplishments:

Low cost spay/neuter Program: We initiated a low cost program in early summer of 2013 to address the large overpopulation of homeless dogs and cats leading to their euthanasia in our county shelter. Primarily through our efforts the euthanasia rate for dogs has been reduced from 74.5% in 2014 to 49.2%. Unfortunately cats have increased from 85% to 87%. Our twice monthly spay/neuter transport averages 21 dog and cats per run. This is down somewhat from 2014 since our grant to provide free spay/neuter to disadvantaged owners expired. We are working diligently to aquire new grants in 2016. Our goal is to ultimately end euthanasia of adoptable dogs and cats in our community. Even though we no longer have the grant to provide low cost spay/neuter to disadvantaged people,we frequently cover the cost.

Education in Schools: In the fall of 2013 we began an educational program for 2nd graders in schools in Randolph County. Since that time we have expanded to four schools with 2nd & 4th graders and educational dog clubs in 3 schools. Retired educators provide lessons focusing on bite prevention, spay/neuter and responsible pet ownership. Well trained dogs are brought into the classroom for student interaction. They have text to read, activities to reinforce their lessons, requirements to meet and are presented with a graduation diploma at the end of the six week session. Almost all the expenses of the class is borne by the educators.

Rescue/Puppy Transport Adoption Program: In order to reduce the number of unwanted dogs and cats in our community, we initiated a rescue and transport program for litters that would normally be bound for the county shelter or worse and put them in a safe place to quarantine, deworm and vaccinate. We then transport them to a no-kill partner shelter in Virginia. Any puppies or kittens not adopted there are transported to North Shore Animal League in NY. It is the largest and oldest rescue and no kill shelter in the country. We run a similar program for adult dogs including the mothers of litters we re-home. We vet check, spay/neuter, vaccinate, test and treat for heart worms if necessary, assess temperament and do basic obedience training to help them succeed in their new home. We hope to increase the number of adoptions by the addition of more foster homes and solicit more donations and grants to help with the program.
