The leadership training programs of the Foundation create and foster enduring academic, professional, cultural, and personal ties between the two countries. The exchange programs enable young Hungarians and Americans to rediscover themselves, gain a better understanding of each other as well as acquire new experiences, professional knowledge, and skills that can be later used to the advantage of their own communities. The leadership-training category includes all those projects and programs that offer internship, scholarship, exchange, and cultural immersion opportunities for talented young Hungarians and Americans.

Education and Research- The Foundation's education and research programs target two main goals. On one hand, the Foundation seeks to operate programs aimed at educating Hungarian Americans from the youngest to the oldest about Hungary's culture, history, traditions, as well as the Hungarian language. The largest Hungarian diaspora today lives in the United States. However, as an impact of globalization, the members of this diaspora, especially the younger generations, find it difficult to maintain their sense of Hungarian identity and are constantly losing their roots. The Foundation is committed to help Hungarian Americans rediscover and cherish their heritage. In case of the older generations, the Foundation seeks to launch programs providing means to preserve the values and noble Hungarian heritage of individuals, families and communities. On the other hand, the Foundation also wishes to take an active part in the educational, academic, and professional exchange between Hungary and the United States. Therefore, it funds and operates programs that promote cooperation between educational and research institutions and professionals.
