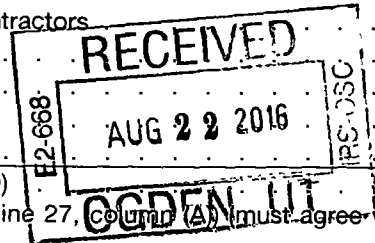

We spent the '15/'16 school year engaged in a pilot collaboration in Manor, TX working with middle school students who also participate in Breakthrough, an out-of-school program for students who will be first in their families to graduate collage. We donated five (5) Apple iPad mini's to help with our student - video recording.

Part III, What is the organization's primary exempt purpose?

The StoryCast project provides students in Pre K - High School with the ability to record thoughts, observations and ideas about their school experiences as a living audio-visual journal. By doing this, we offer students of all ages a unique opportunity to witness their own growth and development and to take stock of lessons learned and skills acquired as they mature into thoughtful and productive members of the of the larger global community.

The Herman Foundation will undertake fundraising programs through phone, mail, email and direct solicitation of individuals including parents, school alumni, friends and supporters of school communities and schools and their respective administrations to pay for audio and video recording equipment where needed, for marketing, for StoryCast website development, for professional services related to education and the StoryCast project and other activities as outlined in Attachment A of Form 1023. The Herman Foundation will also seek grants and funding from public and private charities and foundations with particular interest in education and in the furtherance of oral history, storywriting, storytelling, publishing and digital electronic audio and video archiving.

Part I, Line 16 - Other Expenses

We are engaged in a pilot collaboration with Breakthrough Austin (TX) as part of the design and development work for the StoryCast website. Because The Herman Foundation is Boston-based, travel expense including airfare, taxi, car rental, gas and toll expense is required.
