Apart from being a Director, Linda Barrera is a long-time volunteer of the organization, providing support with our research and writing on the subject of renewable energy. Our organization intervened in a regulatory proceeding with the California Public Utilities Commission and we filed multiple briefs over a two year period, in order to advocate for broader access to community-owned renewable energy, particularly for low-income communities. During a period when we were understaffed and lacked the expertise to complete a particular brief, we decided we needed to hire someone to help. We considered hiring other attorneys, but Linda has substantial experience in this work, far exceeding the experience of anyone else we could think of to hire. Further, her offered rate was \$80 per hour, which is a fraction of the market rate typically paid to similar attorneys. The Board discussed and made the decision to hire Linda, without Linda present in the room. The Board decided that it was in the best interest of the organization and would most effectively advance our charitable purposes to hire Linda to prepare and file the brief. Linda did only 34.75 hours of work at a rate of \$80 per hour.

Response: The organization was managed by all 11 employees, none of whom meet the definition of a "key employee," because none of them made more than \$150,000. All staff receive equal salaries and are expected to participate equally in the management of the organization under a staff governance structure that ensures a high level of integrity and accountability. The directors provide substantial oversight over management activities of the staff.

Response: Two staff worked closely with our accountant to ensure that we have all necessary financial information to prepare the 990. After preparing a draft of the 990, we worked with two additional staff to proof-read the 990, review our responses against the instructions, and cross-check all of the numbers we input. The draft was provided to the Board of Directors, and staff incorporated feedback from the Board.

Response: We keep track of all organizations and businesses in which directors and staff members have an interest. When either directors or staff are contemplating a transaction with an interested person, or with an entity that they are members or owners of, we carefully follow the procedures in our conflict of interest policy, which includes deliberating about the matter, exploring alternatives, and voting on the matter without the interested party present.

We work with an outside accounting and bookkeeping firm, which we hired after weighing multiple accountant options. Three staff members form a financial management committee and review all financial transactions and records. Our Board Treasurer reviews financial statements regularly.
