Mobile Hope's mission is to honor God by building a culture of achievement in mobile home communities where families succeed, students excel, and the community has a hope for the future.

Mobile Hope has been working for almost four years toward the building and opening of an on-site community center within the Maple Hill Estates mobile home park. This center has finally become a reality and opened to the public in May of 2015. Within this center, the local community has access to a 11 station computer lab, a game room for teens and families, a fitness center with 6 machines, a universal gym, and dumbbells, an arts and crafts center, a kitchen, and a large gathering space for events. This was our largest expense of the year and has seen over 12,000 people checked-in for services and programs in the first 6 months of operation. The community has expressed pride and participation in this facility and it allows for over 30 program offerings in the expanded space.

4b (Code:) (Expenses \$ 40323 including grants of \$ 5000) (Revenue \$)
Education: A principle pillar of Mobile Hope is the educational development of students who have been overlooked by either the school system or family. Our largest programs address educational development through a daily homework help program, English language classes, and summer school opportunities. With students often showing a 2-3 year academic gap between them and their peers, this is a high priority. Each week, with the help of over 50 volunteers, we see approx 80 kids come to homework help. Teachers have reported to us that they have never seen such a response rate to the assignments given to students and that their learning rates have improved significantly.
A new program started this year has been a four week summer school program called "Brain Power" to assist students with the summer slide. In partnership with the local school district, funding was secured to hire two teachers to be on-site at the Hope Center for four weeks. With the addition of 30 volunteers, students were given a jump start on the 2015/2016 academic year for three hours a day.

Collaboration: Mobile Hope could not offer the programs available to this community if it were not for the collaborative partnerships that have been arranged between us and other nonprofit and community groups. Currently, we have active relationships with 11 different churches from a variety of denominations, with the school district, the city, the local food shelf, and a variety of service agencies. Through these relationships, we are able to offer social work services and food distribution, counseling services, early childhood services for pre-school children, education and sports opportunities through the school district, health and dental services to kids and families, and even spay and neutering services for pets! We seek to connect the residents of mobile home communities to the many resources available throughout the Twin Cities.
