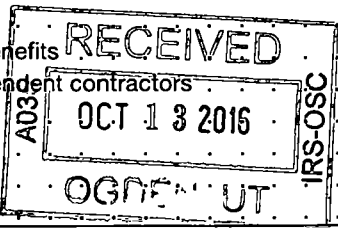




Responsibility Foundation, Inc. filed an initial Form 8868, Application for Extension of Time to File an Exempt Organization Return, prior to the filing due date of May 15, 2016 for its 2015 IRS Form 990-EZ that was accepted by the U.S. Department of the Treasury for a 3-month extension to file by August 15, 2016.

Responsibility Foundation, Inc. needed additional time to compile its 2015 financial data requiring additional time to complete and file its 2015 IRS Form 990-EZ information return. A second Form 8868 requesting an additional 3-month extension to file was completed and placed in the mail box of a rural post office in Colorado that was closed at the time, prior to the first extension to file deadline on August 15, 2016. Unfortunately, the mail was not picked up in accordance with the schedule posted on the mail box that would have post marked the envelope with Form 8868 on August 12, 2016 prior to the deadline to request an additional 3-month extension. The mail must have been picked up late and the postmark on the envelope with Form 8868 was apparently after the deadline to request an additional extension expired based on the IRS letter to that effect.

Responsibility Foundation, Inc. has a small team of dedicated people supporting the organization's mission. We will have systems in place to make sure this does not happen again in subsequent years.
