

FEEDING & WINTERIZATION PROJECTS

WAM issues grants to partnering agencies in the Middle East Region for the purpose of purchasing local food, warm clothing, tents, blankets, etc. to refugee survivors of war who are underserved by local and international organizations and governments. WAM staff make frequent visits to identify areas of underserved populations, build relationships with partnering organizations and churches and are frequently on site during distribution of life saving food & supplies

Over 10,000 individuals have been fed and provided with warm clothing & shelter at an approximate cost of \$20 per person

GENERAL RELIEF PROGRAM

WAM staff organize relief efforts with other organizations to collect donated food, water, medicines, medical supplies, diapers, hygiene kits, blankets and tents which are then shipped to Syrian refugees located in Jordan, Iraq and Lebanon.

WAM coordinated and paid for the shipment of five 40 foot containers filled with donations valued at approximately \$1,250,000.

Each shipment contains enough donated items to help support 600 families with an average of 6 members in each family.

In 2015, the 5 shipments provided much needed relief to approximately 18,000 individuals at a cost of \$4 each.

SYRIAN WOMEN'S HANDICRAFT PROJECT

WAM advocates on behalf of this project to encourage people to purchase handicrafts as a way to foster economic sustainability for the Syrian refugee women. WAM financially contributes to the "Needle & Thread Project" which was created to support displaced Syrian mothers and to help them make & sell their handicrafts so they can support their families rather than become dependent on meager charity donations.

In 2015, WAM provided a grant of \$2,775 which assisted over 100 women at a cost of approximately \$25 each.

Monitoring of grants - WAM receives requests from partner organizations (churches) and individuals located throughout the Middle East Region who have been vetted by WAM's Officers. An understanding of the subrecipient's background and history is documented and research is conducted to assure that WAM's grants are not funding a cause that is already funded by other organizations. Grants are awarded based on what the WAM Officers observed in field visits, strategy & purpose alignment. Subrecipients are required to turn in mid-term and final reports detailing statistics of persons served, demographics, etc. Documentation, pictures, narrative reports and financial accounting is required at the end of the project. WAM Officers are usually present when the grant is being utilized for additional oversight and better understanding of needs.

The Accrual Method of Accounting is used for reporting grants issued. All grants issued are reported in the accounting software (QuickBooks) noting type of payment issued, such as wire, cash, check, etc. and the name and location of the grantees.
