FEEDING & WINTERIZATION PROJECTS

WAM issues grants to partnering agencies in the Middle East Region for the purpose of purchasing local food, warm clothing, tents, blankets, etc. to refugee survivors of war who are underserved by local and international organizations and governments. WAM staff make frequent visits to identify areas of underserved populations, build relationships with partnering organizations and churches and are frequently on site during distribution of life saving food & supplies

Over 10,000 individuals have been fed and provided with warm clothing & shelter at an approximate cost of \$20 per person

GENERAL RELIEF PROGRAM

WAM staff organize relief efforts with other organizations to collect donated food, water, medicines, medical supplies, diapers, hygiene kits, blankets and tents which are then shipped to Syrian refugees located in Jordan, Iraq and Lebanon.

WAM coordinated and paid for the shipment of five 40 foot containers filled with donations valued at approximately \$1,250,000.

Each shipment contains enough donated items to help support 600 families with an average of 6 members in each family.

In 2015, the 5 shipments provided much needed relief to approximately 18,000 individuals at a cost of \$4 each.

SYRIAN WOMEN'S HANDICRAFT PROJECT

WAM advocates on behalf of this project to encourage people to purchase handicrafts as a way to foster economic sustainability for the Syrian refugee women. WAM financially contributes to the "Needle & Thread Project" which was created to support displaced Syrian mothers and to help them make & sell their handicrafts so they can support their families rather than become dependent on meager charity donations

In 2015, WAM provided a grant of \$2,775 which assisted over 100 women at a cost of approximately \$25 each.
