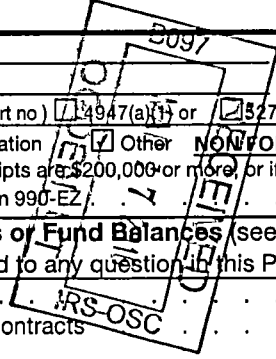



Line 10 - Grants were provided to two organizations for the support of the children at each orphanage. In addition grants were provided to one church in Pino Gordo, Guatemala in support of the church ministry to kids and families in the community.

\$6,098 went directly to GOD BLESS THE CHILDREN HOME - located at 0 Calle 16-26 Zona 15 Colonia El Maestro, Guatemala City, Guatemala

\$13,053 went directly to New Life and Peace Ministries - Rehoboth Home in Paramous, Guatemala - 3051 Cloverdale Road, Florence, AL 35633

\$1,670 went directly to the Church and School in Pino Gordo, Guatemala. Funds were used to build a single room home on the back of the church and facilitate a medical clinic for the area children and families.

Grant funds were used for education, food, clothing and ongoing home support.

Part IV. None of the officers are compensated. There are no paid employees and administrative personnel at this time. All administrative work is done by volunteers and directors.

Line 16 - Other Expenses are the project expenses related to the missions team that worked at the Rehoboth Orphanage and God Bless the Children Orphanage in 2015 as well as expenses related to the medical clinic done in Pino Gordo. Project expenses were for Medical Supplies for the rural clinic and construction supplies for the work at both Orphanages.

Breakdown of expenses of Line 16 consist of \$17,375.35 airfare transportation, \$3704.66 Hotel and Lodging expenses, \$3620.94 team member meals, \$9674.20 project expenses for medical, construction, and supplies.

Line 31 - Other Program Services are the same expenses as explained for Line 16.
