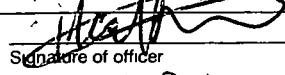

REPRESENTATION: The organizations' attorneys represent people who have protected income for purposes of receiving
communication from collectors, so the clients do not have to deal with the fill collectors ever again. The attorneys receive
communication from the bill collectors on a ongoing basis. No person who qualifies for these services is ever turned down for
lack of being able to pay for services. Approximately 1/3 of clients receive service at no cost. Cease and desist letters are also
provided by the organization for free on the website and in physical handout form.

EDUCATION. To educate the public about seniors' financial rights. There is a very limited amount of information available concerning
the financial rights of the impoverished elderly. As a result, many individuals spend their limited retirement unnecessarily on old debt
and are left wanting for basic needs. The organization educates seniors and disabled and persons working with seniors about the
financial rights of seniors and disabled with limited income. This is done by speaking at conferences, presenting to civic groups
about seniors financial rights, and distributing newsletters with timely and applicable articles. These are all provided at no cost.
