The Basic Utility Vehicle (BUV) is a highly effective transport vehicle manufactured on-site and distributed to low-income entrepreneurs through the rent-to-own program. BUVs allow people to immediately begin to earn an income as they launch their own transport business with these affordable, rugged yet simply maintained vehicles. We provide on the job training for the men in the manufacturing sop, and owner/operator training to the men and women who qualify for our rent-to-own program. Completed 3 week long BUV Driving Training sessions for new owner/operators, resulting in 16 new certified drivers. The Basic Utility Vehicle was awarded First Place in transport sector or international Trade Fair Show in Dar es Salaam. Exported BUVs to Uganda and Kenya.
