Summer Jobs for Youth - As a means of addressing juvenile crime during the summer months, IPSF led an effort to raise funds for organizations in the Indianapolis community who provided summer youth employment opportunities. These organizations not only provided opportunities for youth (typically ages 16 to 19) to earn money through work, but also provided additional career-building training such as resume development, interview preparation, basic finances and more.

Graffiti Abatement Unit - Graffiti plays a major role in not only increasing blight in neighborhoods throughout Indianapolis, but also serves as a means for criminal communication. IPSF developed the Graffiti Abatement Unit (GAU), which operated 35 hours per week and abated over 15,000 square feet of graffiti at over 220 commercial or residential properties. The GAU provided opportunities for re-entrants to work on the GAU and allowed them to engage with public safety for education, training and mentorship.

IMPD Leadership Academy - The IMPD Leadership Academy (IMPDLA) was developed to provide additional leadership training to police officers and other first responders throughout the greater Indianapolis area. The program utilizes best practice leadership training models from throughout the country to provide first responders - typically those in a leadership role or those seeking leadership roles - with tools, techniques and resources to be better leaders and better engage with the community.
