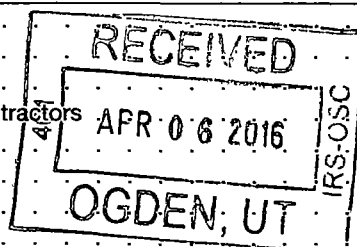

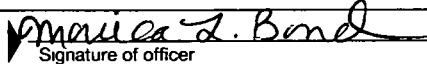

Other program services include expenses not directly related to a single program. These expenses include: vehicle repairs and maintenance, Tanzania field station expenses (food, rent, utilities), post office fees, bank fees, travel, Wild Nature Institute t-shirts for promotion.
