IT CATALYZES SOCIAL VENTURES LED BY UNDERREPRESENTED ENTREPRENEURS, PARTICULARLY PEOPLE OF COLOR AND WOMEN. WE BELIEVE THAT GENIUS IS EQUALLY DISTRIBUTED, BUT ACCESS FOR SOCIAL ENTREPRENEURS IS NOT.
