Dunning 2015, Without Borders, Inc. has executed three projects at homeless missions (feed the hungry program), free surgeries, and sponsored the publication of 4 educational books within the US. We have also reached more than 1700 displaced families in three countries in the Middle East, Iraq, Syria, and Lebanon, providing boxes of food material (50-100 pounds per each family). The organization also provided back to school supplies for over 1000 students in Syria. On the medical missions, we have sponsored the treatment of a dozen of children and adults in Jordan, Iraq, and in the US.
