Development and maintenance of TAIR (The Arabidopsis Information Resource), a database of scientific knowledge about the genome and proteome of the reference plant arabidopsis thaliana. New scientific information was extracted from 2332 research articles and associated to 4949 arabidopsis genes. The TAIR scientific database served the public with other two million separate visits to the site and over 15 million individual page views, and average 60,000 unique visitors per month.

Development of long-term sustainable sources of funding for scientific databases to support their operations and enhance their ability to serve the research community. We developed a cloud-based subscription platform with the capacity to support databases external to Phoenix Bioinformatics, allowing such databases to remain at their host institution while still benefitting from our services. We also established a legal, financial and operational framework that will enable us to assist databases hosted by external organizations with the transition to subscription support.
