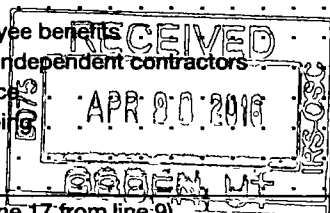

Result: This past year we had several different events seeking to be culturally relevant and help communities in their needs. We impacted over seven hundred different people in five distinct events to help teach Christian values to impoverished children and families.

Goal: Meet Spiritual needs within the given culture and community through the preaching and teaching of the Bible.

Result: Within the community, GTM Executive Director, Brian Miller teaches the Bible in different types of settings (community centers, homes, businesses, schools, and universities) 6 days a week. Weekly over 130 people within the community are having their spiritual needs met through various teachings and activities.

As well, GTM helped to establish a Christian community by providing for spiritual retreats, material for mass evangelism, part of the payroll for a local leader, etc.

Part III Statement of Program Service Accomplishments #30

Goal: Develop ministries to meet the physical and emotional needs of abandoned and/or exploited children, youth and adults by providing rehabilitation for drug addictions and support for victims of sex trafficking and abandonment. Assistance shall include, but is not limited to, food, clothing, shelter, education, counseling and psychosocial training skills.

Result: This past year the ministry worked with the impoverished school in Medellin to prevent sex trafficking and bring healing to abandoned children. Weekly we were able to encourage and bring healing to over 30 children through counseling and teaching with abandoned and/or exploited children. As well, it has invested financial resources in other ministries throughout the world that are helping abandoned and/or exploited children in places like Honduras, Haiti, Ohio, etc.

Part III Statement of Program Service Accomplishments #31

Goal: Develop local leaders to impact their communities and beyond with Christian values and equip them with the necessary resources.

Result: Brian Miller, GTM Executive Director, equips local leaders by teaching two different courses in the Colombian seminary, impacting over 60 local leaders. On 3 different occasions a GTM associate had an opportunity to train local leaders in how to lead in their communities. Over 200 leaders were challenged to grow in their leadership skills to impact their communities and beyond with Christian values.
