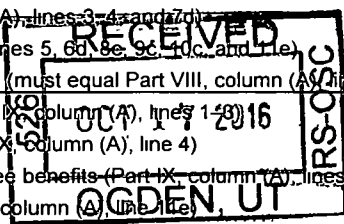

The Grace Bridge Eye Care Clinic opened with local optometrists providing their time and services free of charge to meet this important need. Our

clinic serves 15-20 participants of all ages each month with additional scheduling at the beginning of the school year.

The Grace Bridge holds an annual "Bikes and Bibles" event by partnering with a group of men in Celina. Each year we focus on a specific community in our coverage area to touch the lives of children by providing them the opportunity to have a new bike and hear God's Word.

The Grace Bridge launched a resale store as a source of clothing for our participants and community. We soon were receiving clothing and home good donations and have been able to assist families in need with furniture and appliances.

Grace Bridge continues to provide and develop our services with the purpose of meeting people's needs to provide hope for the future. Our goal is not to simply distribute food or provide families with essential items needed for survival, but also to develop lasting relationships that, over time, will allow those who receive help to return and help others.
