Education Grants

The 2015 portions of four education grants are reflected in this program category. Included are a PhD student completing his studies and preparing to defend his thesis, a MDiv candidate completing the first year of a three year, post-graduate theological studies program, and a physician in training completing his first year of medical school, and a former pastor in crisis who is retraining professionally in construction management

Strait Clinic in Kalaymyo, and mobile medical missions in Myanmar

Expenses in this program category reflect the second year of a two year commitment to renovate and staff a medical clinic operated by the Chin Baptist Association in Kalaymyo City, Myanmar

Not reflected in these numbers are the volunteer time of US medical personnel who travelled to Myanmar for clinic based and mobile medical missions on 5 trips during 2015, or more than \$100,000 in travel and donated medical supplies which were not reflected in Roger H Strait Memorial Foundation transactions. Also not included are more than \$24,000 contributed in 2015 by Lai Chin Baptist Church of Frederick, MD towards clinic renovations and support, and at least \$20,000 in cash and kind from other Chin Baptist Churches which was contributed directly to this project and not thru the Roger H Strait Memorial Foundation

Elementary Student Subsidy Initiative (ESSI)

ESSI is a village based after school program which incentivizes public school attendance and teaches English (a required core course from primary through secondary school in the Myanmar public education system) using the minority Chin mother tongue (rather than Burmese) as a language of instruction. Minority language students in rural Myanmar typically underperform or drop out of public school - which uses only Burmese, a new language for most of them. This program is successfully addressing this need.

Launched in 2015, the ESSI program expenses include costs for curriculum development, translation, printing, teacher salaries, and teacher participation in biannual English learning intensives. At the end of 2015, approximately 30 villages were being served, with 25-40 students per class.

Not included in these numbers are the volunteer time and more than \$30,000 of travel and related conference costs involved in two English language intensives, which brought together 8-10 US and other expatriate volunteers who travelled to Myanmar at their own expense, with up to 40

ESSI teachers for week-long learning sessions. Also not included are more than \$30,000 of direct contributions to ESSI program costs in Myanmar by individuals and churches which did not pass thru Foundation accounts.
