HNC Living Foundation was formed with the specific mission of helping head and neck cancer patients live life fully, during and after treatment, through financial aid We do this primarily through grant funding to nonprofit organizations and healthcare providers to support programs, services, or treatments that provide direct benefit to head and neck cancer patients during their treatment and/or recovery Individual assistance also may be available directly through the Foundation Since organizing in 2014, we have funded nearly \$244,000 in grants in the Kansas City area For many head and neck cancer patients, the financial challenges of dealing with their diagnosis are just as overwhelming as the medical challenges All too often, these patients forgo treatments and therapies that can improve their quality of living because there is no insurance coverage or no money Our grant funding is supporting programs that are providing pre-treatment dental care, post-treatment dentures, nutritional support, prescription assistance, medical equipment and supplies, and case management support Additional information about the grant funded programs is on Schedule I Although starting local, our vision and commitment is to become the national resource of financial assistance for head and neck cancer patients And, our promise is that money raised in any community will be granted back to assist patients in need in that community
